\$25,001.00 to \$50,000	\$559.45 for the first \$25,000 plus \$14.50 for each additional \$1,000, or fraction thereof, to and including \$50,000
\$50,001.00 to \$100,000	\$921.95 for the first \$50,000 plus \$10.00 for each additional \$1,000, or fraction thereof, to and including \$100,000
\$100,001 to \$500,000	\$1,421.95 for the first \$100,000 plus \$8.00 for each additional \$1,000, or fraction thereof, to and including \$500,000
\$500,001 to \$1,000,000	\$4,621.95 for the first \$500,000 plus \$6.80 for each additional \$1,000, or fraction thereof, to and including \$1,000,000

Other Inspections and Fees:	
1. Inspections outside of normal business hours.....	\$47.00 per hour ¹ (minimum charge—two hours)
2. Reinspection fees	\$47.00 per hour ¹ (a fee may be charged for inspections that require more than 1 reinspection)
3. Inspections for which no fee is specifically indicated.....	\$47.00 per hour ¹ (minimum charge—one-half hour)
4. Additional plan review required by changes, additions or revisions to approved plans.....	\$47.00 per hour ¹ (minimum charge—one-half hour)
5. For use of outside consultants for plan checking and inspections, or both.....	\$Actual costs ²

¹Or the total hourly cost to the jurisdiction, whichever is the greatest. This cost shall include supervision, overhead, equipment, hourly wages and fringe benefits of the employees involved.

²Actual costs include administrative and overhead costs.

Plan Review Fees. When submittal documents are required by IBC Section 109, a plan review fee shall be paid at the time for submitting the submittal documents for plan review. Said plan review fee shall be **75%** of the building permit fee as shown in City of DuPont Fee Table.

Note: A \$4.50 BCC (Building Code Council) Fee will be added to all *building* permits.
