\*\*\*CRIME UPDATE: DUPONT ARMED ROBBERY SUSPECT ARRESTED\*\*\*

During the evening of November 17, 2022, an armed robbery was committed at the Jack-In-The-Box Restaurant located at the 1200 block of Center Drive by an unknown male. DuPont officers and investigators subsequently conducted an investigation, and the below bulletin was disseminated the following day (including a post made on this Facebook page). We received several tips. One of them, from an anonymous DuPont citizen, provided our investigators with a strong lead, which resulted in the identification of the primary suspect (pictured below). That information was sent to surrounding agencies to "be on the lookout" for the suspect.

Last night, DuPont Police Department (DPD) patrol officers were dispatched to assist police officers with the [Steilacoom Department of Public Safety](#) (SDPS) for an unrelated, in-progress disturbance occurring within their town. DPD Officers arrived minutes later and discovered that one of the parties involved in the "disturbance" was the suspect in the aforementioned armed robbery. DPD and SDPS officers took the suspect into custody without incident. DPD officers booked the suspect into the Pierce County Jail for 1st Degree Robbery, while the suspect's vehicle was towed to the DuPont Police Station as evidence. DPD officers have subsequently submitted a Search Warrant for any evidence that maybe related to the November robbery.

Over the past several months of this investigation, in working with surrounding agencies, DPD investigators have determined that this suspect may have been involved in other felony crimes within the Pierce County area outside of DuPont. We are currently working with those agencies, supporting their respective cases, and notifying them that the subject is in custody.

This arrest is the result of diligent work by DPD investigators, exceptional police work and speedy response by DPD patrol officers, the support and teamwork during the duration of this investigation from the Steilacoom Department of Public Safety – and MOST OF ALL, the involved DuPont citizen (who wishes to remain anonymous) who had the initiative to help our community. The DuPont Police Department is seeking any information which may assist in the identification of the subjects involved in the armed robbery of a Jack-In-The-Box Restaurant located in the City of DuPont, occurring on November 17<sup>th</sup>, 2022 at 5:30pm.

The above pictured subject was the passenger in the above vehicle, which parked in the drive through lane. The suspect entered the restaurant through the drive-through window while brandishing an unknown caliber, shoulder-fired handgun, taking the cash from the register. Victims/witnesses described the male suspect as black male with a full gold-metallic teeth covering, black "Polo" hooded sweatshirt, thin build, approximately 6' to 6'2" and spoke with a noticeable accent (victims describing the tone as possibly from Florida or Louisiana). The vehicle (possibly a 2003-2008 Infinity FX35 with no license plate, but bearing an unknown dealership placard and after-market dark wheels) was driven by an unknown male, "heavyset" female. DuPont Police patrol units arrived within three minutes of the 9-1-1 call to find the vehicle had left the area in an unknown direction.
