- Officers were dispatched after receiving a report of a possible vehicle prowler. When officers arrived, an individual was stopped that matched the description of a person suspected of prowling vehicles. The individual, who is a juvenile, was turned over to their guardian. Various charges were referred to the Prosecutor.
- While on patrol, an officer observed a vehicle that had crossed over the fog line multiple times and proceeded to make an unsafe turn nearly colliding with another vehicle. Once the driver was pulled over, a field sobriety test was conducted. The driver was found to be driving under the influence and was arrested.
- Officers responded to a report of a male and female arguing in an alley way. Once officers arrived it was determined that the male had violated a court order. Charges have been referred to the Prosecutor.
- A speed emphasis was conducted on Steilacoom DuPont Road and Center Drive.
