NEWS FROM PATROL

- During a routine patrol, an officer observed a vehicle stopped in the middle of a city roadway. Once the officer approached the vehicle and began speaking with the occupants, the driver exited the vehicle and walked away. While speaking with the passengers and verifying their identity, it was determined that one passenger had an active warrant from the Spokane Sheriff's Department and was also in possession of a concealed weapon without a license. A K9 unit from a neighboring agency assisted in locating the driver who was found to have an active warrant from Department of Corrections. Both individuals were arrested and booked into jail.
- An officer observed an individual at a local gas station that was acting suspicious. After a records check, it was determined that the vehicle owner had an active warrant from the Pierce County Sheriff's Office for a Hit & Run. He was arrested and booked into jail.
- A traffic emphasis was conducted on Steilacoom DuPont Road and Center Drive.
